#### THE XL VIT IN COURT

A well-informed professional will have no difficulty substantiating the use of the XL VIT as a valid tribometer. However, **EXCEL TRIBOMETERS, LLC** all too often receives calls from testifying professionals or attorneys who ask (usually after an adverse ruling) why the opposition could challenge use of their XL VIT on the basis of ASTM F2508. Our first question to them is do they have the ASTM F2508 standard and have they read it, or have they read any of the **EXCEL TRIBOMETERS, LLC** <u>Newsletters</u> in the past 2 years, or have they read and did they follow the current XL VIT User Guide when they performed their testing, or have they reviewed the available information on the Excel Tribometers LLC website.

Any person who holds her/himself out as an expert in walkway safety and tribometry who does not have the foundation and knowledge to defend the criticism that their particular XL VIT is not F2508 calibrated is ill prepared. You must actually purchase, read, and understand the standard. You must purchase, read and understand the articles referenced in the standard. You must know all the information available on the **EXCEL TRIBOMETERS, LLC** website.

An additional available tool to confirm the validity of the XL VIT is the list of cases where the XL VIT has been successfully recognized by the court, which has been compiled by Keith Vidal. Anyone who wants to perform a competent risk assessment of a walkway, or evaluate flooring and footwear products, needs to establish a strong foundation in the principles of safety engineering, the sciences of walkway safety, the scientific and mechanical aspects of the available slipmeters, and the effects of reasonably foreseeable variables on the performance of walkways and slipmeters. #### F2508 CALIBRATION

Do you need to have the F2508 Calibration performed on your XL? The best answer is "it depends." If you are in an environment where you need to represent you have an ASTM F2508 Validated walkway tribometer, then "yes" you need to have a current F2508 Calibration, since F2508 <u>Calibration</u> is part of the F2508 <u>Validation</u> process, as defined in the standard practice. **EXCEL TRIBOMETERS, LLC** offers F2508 Calibration for those who request it at the time of purchase of a new instrument for \$750.00. For F2508 Calibration

at any other time for any XL VIT, the fee is \$950.00. Due to the extensive testing required, please call ahead to schedule your F2508 Calibration.

If you desire to conduct the ASTMF2508 Validation and Calibration of your XL VIT, you must purchase the required chemicals yourself. **EXCEL** 

**TRIBOMETERS, LLC** does not sell those materials. Then you must follow the instructions contained within the standard to prepare the specific concentrations of each.

### **INSTRUMENT CALIBRATION AND REFURBISHING SERVICE**

Your XL VIT is a scientific instrument and requires regular instrument calibration and refurbishing, as with any similar credible metering device. The fee for XL VIT instrument calibration, if you are on time, is \$250. For those of you who are not current and your slipmeter is overdue, we are offering new standard pricing of \$350 plus parts, which encourages overdue XL VIT users to bring their instrument up to date.

Please keep in mind that if you maintain your tribometer by sending it for the XL VIT instrument calibration service at the proper intervals, **we will repair anything** within 6 months following service, for shipping costs only, unless there is clear evidence of physical abuse or extraordinarily extensive use. Some machines are shared by many and used constantly. Those slipmeters need servicing more often.
